## **Reports:**

### President:

- Sandie Attended a Zoom SCAN meeting. Saanich council is again discussing attaching a councilor to each Community Association for enhanced communication, but no details are available yet. Vernon noted that this might make it easier when a community member has a question for Saanich. Vicki added that this approach may not be as versatile as the present system, when any councilor can weigh in for assistance.
- Saanich will provide up to \$500 toward a community association insurance policy for liability during events or possible suits against its directors. Six associations are currently under a Saanich plan. The board discussed pros and cons of using saanich or going alone for coverage and what risks are involved with no coverage. A motion was put forward by Sandie and seconded by Vickie as follows – Sandie to contact Catherine Whitworth of SCAN to get more details on the Saanich liability insurance plan. Motion was passed.
- Lisa asked if Saanich has written guidelines on how a community association should be run. Vicki said she will inquire if such exists.
- My Tolmie Association Horner Park upgrade is going ahead.
- Saanich is considering allowing Food trucks at Music in the Park future events.
- Property occupied by the Bird of Paridise Pub and two adjacent lots has a development proposal for 151 rental units'
- Brodie fro Mt. Tolmie has hears that Abstract Developments now have revised proposals for their Shelbourne at Freeman and McRae projects. Vicki will confirm and report back.

## Treasurer:

 Vernon – Bank balance is \$3647.54, same as last month, with no new expenses or revenue.

## AGM:

• We will reschedule for the Fall but will have to consider size limits for social distancing or rent a gymnasium. These details will be discussed later.

#### **Development:**

- 3821 Cedar Hill Rd- To Rezone from RS-6 (Single Family Dwelling) zone to RT-FC (Attached Housing Four Corners) zone to construct 4 new homes (2 Single Family Dwellings and 1 Duplex). Several letters written to Planning/council in objection to the proposal with notable issues being density on the lot, height of retaining wall around project and not being consistent with the neighborhood building characteristics.
- Lisa asked if the survey results were complete for the Abstract developments on Shelbourne at Freeman and McRae- discussion ensued.

#### Shelbourne Community Kitchen:

• The kitchen is showing a major increase in demand for their services. In order to receive certain funding they have needed to label their status as a "Food Bank"

#### New Business:

- Andrea reported that the Bowker Creek Initiative has a new director in Lindsey McCrank, taking over from Kitty Lloyd.
- Nothing new to report on the Kings Nature Green Space re fundraising efforts, or response from the CRD.
