Developments:

- Re 3401 Shelbourne St/Freeman project by Abstract Vicki previously responded to council that the CCA is in opposition to the latest amended version. She spoke to Adam cooper on behalf of a concerned neighbor who wanted interaction with the developer.
- Lisa suggested that we add the names of Saanich councilors and their emails to our website, so as to allow the community to correspond in relation to developments in our area.
- Vicki advised the board of an upcoming 2-3 bedroom Townhouse project at 2859 Richmond Rd.
- Vicki Tuesday Sept. 15th Saanich council Committee of the Whole meeting to amend 2 zoning bylaws from 2003. The **First** is a proposed amendment to residential zones to allow the issuance of for the sale of homegrown and value added fruits, flowers, vegetables and homemade crafts at roadside stands. The **Second** amendment to zoning bylaw 2003 is to recognize garden suites as permitted land use in certain RS -zones and to establish conditions and regulations fort their use.

Note that a previous Open House has been held. Lisa and Vicki will create an information document and send via Mailchimp to our members before the meeting. Note that the Saanich planning department recommends council support the regulatory framework for garden suites adoption.
